The notion of 'person' and 'personality' in terms of comparative law, natural persons and legal persons (associations and foundations), capacity to have rights, capacity to act in law and act of injustice, assaults in personal rights, protection of personality and protection of private life and human's dignity, name, kinship and habitation, register of births, deaths and marriages are examined.
